## The 5 main italian insurance companies (Allianz, Intesa Vita, Generali Italia, Poste Vita, Unipol SAI) will become the new counterparties of Eurovita policy holders

**Trento, 03.07.2023**, upon the initiative of the Ministry of Economy and Finance, Ministry of Enterprises and Made in Italy, and with the collaboration of the Supervisory Committee and the Extraordinary Commissioner of Eurovita, it has been reached an agreement among 25 banks distribuiting Eurovita policies, the 5 main italian insurance companies (Allianz Italia, Intesa Sanpaolo Vita, Generali Italia, Poste Vita and Unipol SAI) and a pool of italian credit institutions (Banco BPM, Banca Monte dei Paschi di Siena, BPER, Credit Agricole, Intesa Sanpaolo and Mediobanca), for an operation aimed at protection of Eurovita policy holders.

IVASS and Bank of Italy have closely monitored the operation's definition within their institutional roles and have welcomed the agreement.

The essence of the endeavor, shared by all the participants, is aimed at guaranteeing the full protection of investors who subscribed Eurovita policies: in this framework, indeed, it is envisaged that, upon completion of the operation, the entire insurance portfolio of distributors banks (listed below) will be taken over by the five companies that will therefore become the new reference insurance companies for current customers. Furthermore, the plan requires, as an intermediate technical step, the initial transfer of the policies to a newly established insurance company, which will be fully owned by the five insurance companies mentioned.

Distributor banks, in addition to providing an update on the progress of the negotiations, will communicate to the customers, in a subsequent phase, which insurance company becomes the new counterparty, and will support them for any need.
